


Figure 1: The MA 10 crosses down the MA 20




Figure 2: CCI signaling a potential oversold condition




Figure 3: Aroon Down crossing above the Aroon Up




Figure 4: Signal line positioned above the MACD line




Figure 5: RSI declining from 80

# **Technical Analysis**

In Figure 1, the recent MA 10 crossing below the MA 20, while the price remains under the MA 20, potentially signals a bearish trend. Additionally, In Figure 2, CCI briefly fell below -100 at 14.12.2023, signaling a potential oversold condition, yet caution is advised due to the lack of a clear trend. In Figure 3, the Aroon Down crossing above the Aroon Up on 12.12.2023, concurrent with the MA 10 crossing the MA 20, potentially signals a sell opportunity indicating a shift towards a bearish trend. Furthermore in Figure 4, the Signal line positioned above the MACD line, both trending downward in the past month, suggests a potential bearish sentiment. Lastly in Figure 5, the RSI declining from near 80 at the beginning of the month implies a potential decrease in buying momentum.

#### **Prediction**

With technical indicators signaling a potential sell stance for Microsoft in the short term, it's advised to proceed cautiously due to recent positive fundamental advancements.
