Technical Analysis

According to Figure 1, the main graph shows that the stock price has been above both the 10-day and 20-day moving averages since December 12th, 2023. Alongside the upward trend of the stock price and both moving averages, the market psychology appears confident, providing the first 'buy' signal. Additionally, the 'Aroon Up' line being above the 'Aroon Down' line, as shown in Figure 3, is considered another favorable signal. Also, according to the Directional Movement Index (DMI) (Figure 2), the +DI line is above the -DI line, indicating an upward price movement.

Contrary to the information derived from the aforementioned indicators/graphs, there are other indicators that are less optimistic. Moreover, a concurrent signal arises from the MACD and RSI indicators as well, with the MACD line below the signal line and the RSI rising exactly at 70, signifying a overbought situation in the stock and, therefore, a 'sell' signal for stock traders.

Prediction

Based on the information from each indicator, it is evident that a divergence scenario is present in the analysis of Accenture's stock. Taking into account the positive news regarding the company, while the stock currently maintains a neutral position, there is certainly potential for future growth and a favourable ROI.
