


Figure 1: Stock graph shows the bullish trend



Figure 2: Candle chart shows that the green candles are the majority.




Figure 3: MACD indicates a potential buy signal.




Figure 4: CCI Indicator




Figure 5: PPO depicts a potential buy signal.

#### Firm's Brief Description

Ferrari NV, known as Ferrari, is an Italy-based designer, manufacturer and retailer of sports cars that is incorporated in the Netherlands. It operates under the Ferrari brand. Its sports cars portfolio includes, among others, F12berlinetta, FF, Ferrari 488 GTB, 488 Spider, 458 Speciale, Ferrari California T, F12tdf and LaFerrari. The Company also offers financing services through Ferrari Financial Services. It also produces limited series and one-off cars. The Company divides its regional markets in EMEA (Europe, the Middle East, India and Africa), Americas, Greater China and Rest of APAC (Asia-Pacific region, excluding Greater China) and is active in over 60 markets worldwide through a network of authorized dealers.

## Fundamental Approach

- Demand for Ferrari supercars bounces back to Pre-Pandemic Level.
- Ferrari finds buyers in Singapore despite the Pandemic, with a 2020 demand reaching 90% of 2019.
- Ferrari unveils a drop-top version of its debut plug-in hybrid, in a bid to make 60% of sales from hybrid technology by 2022.

### **Technical Analysis**

According to the examined period, from 3.11.2020-3.12.2020 there are 4 secondary movements. Overall, the movement is bullish. In figure 1, the MA10 is moving above MA20 indicating a potential buy signal. Moreover, in the second graph, the majority of the candles are green. MACD in figure 3 provides a potential buy signal as is fluctuating above zero line and the histogram has already started to converge to the zero line as well. In the 4<sup>th</sup> graph, CCI is set above +100 level, providing a buy signal. Finally, in the figure 5 PPO is positive as the short-term MA is above the long-term MA.

#### Prediction

Considering the strong bullish trend of this stock combined with the expecting new plug-in hybrid model in the upcoming years, establish a potential buy signal. Moreover, for a weekly and monthly period, technical analysis signals suggest a bullish trend. The strong rebound for demand to the pre-pandemic levels and more particularly the high demand coming up to 90% of 2019 in Singapore, reveals a healthy and promising a-lot company.
